# SECTION-I (PART-A) INSTRUCTIONS TO e-TENDERERS ANDGENERAL TERMS AND CONDITIONS OF eTENDER

#### ITEM NO.01

# ALLOCATION OF CUSTOM PROCESSING PLANTS AT VARIOUS LOCATIONS IN MAHARASHTRA,

# NAME OF LOCATION: CHIKHALI DIST. BULDHANA

Maharashtra State Seeds Corporation Limited, Akola is interested to Allocatethe Custom Processing Plants for Processing of Seeds of various crops and varieties of Cereals, Pulses, Oil seeds like Soybean, Gram, Wheat, etc., which are produced by MSSCL on Custom basis for a period of Two Years from 01.12.2025 to 30.11.2027 (which covers Kharif 2025-26,2026-27 Rabi 2025-26,2026-27 season).

The online e-tenders in two bid system are invited from the Reputed and Experienced Custom Processing Plant Owners who have got Seed Processing facilities such as Storage Godown, Seed Processing Machineries like Seed Cleaner-cum-Grader, Sp. Gravity Separator, Spiral separator, Seed Treater, Destoner, Magnetic Separator, Elevator, Flight belt Conveyor, Storage Bin, Weigher-Bagger, Sealer, Moisture Meter, Bagclosers, Electric Supply etc. and Trained and Professional Man-power for operations and management of seed processing plant in both Kharif and Rabi Seasons. The Start-ups and Newly Established Seed Processing Plant owners may be considered by MSSCL after due verification but they will have to submit the undertaking to obtain the License from MS Seed Certification Agency.

#### Quantum of Seeds for Processing available for Custom Processing:

It is expected that the sizeable quantity of fresh stock may be available in Kharif and Rabi seasons. Tentatively following approx. quantity may be available for custom processing during Kharif 2025-26 season:-

The quantity may vary depending upon the season and vagaries of nature. MSSCL will first reserve quantity to utilize its own capacity and remaining quantity will be allotted to Custom Processing Plants, so quantity for processing cannot be assured. MSSCL does not take guarantee to provide the quantum of availability as it may be affected by natural factors/ any other decision of the management. The quantity during remaining seasons for custom processing, if available will be informed time-to-time after receipt of raw seed. The quantity at each plant will vary season to season and year to year. The location of the Seed Processing Plant should be around production area convenient for transportation of raw seed to MSSCL seed growers. MSSCL may allot to more than one custom processor in one district, if required depending on need.



### **Period of Contract:**

This contract will be for a period of **Two year**i.e. from **01.12.2025 to 30.11.2027**, which covers Kharif 2025-26,2026-27 & Rabi 2025-26,2026-27 seasons and if mutually agreed, it can be extended further at the same rates and same terms and conditions.

# Eligibility as a Custom Processor/ Contractor:

- 1. The processing Plant of the Custom Processor has to be registered with Maharashtra State Seeds Certification Agency and License should have been renewed till current year i.e. September-2025 and be applied for renewal. For newly established Plants or in case the license is not renewed by Seed Processing Plant with MSSCA, it will be responsibility of Custom Processor to get the license before start of raw seed arrivals or processing at their plant.
- 2. The Custom Processor/ Contractor should be experienced in carrying out custom processing of Cereals, Pulses, oil seeds like Soybean, Wheat, Gram and seeds of many other crops and varieties.
- 3. The Custom Processor/ Contractor should have minimum 4 TPH seed processing machinery like Seed Cleaner cum Grader, Sp.Gravity Separator, Seed Treater, Spiral separator, Magnetic Separator, Z Type Elevator, Flight belt Conveyor, Storage Bin, Weigher Bagger, Sealer, Moisture Meter, bag closer etc. in good condition and having capacity 4TPH so as to complete the processing of above quantum of seed in Kharif Season from December to March and in Rabi Season from July to September. The make of the machinery must be from the following reputed companies like M/s Fowler Westrup/ John Fowler/AGROSAW/ Krishi seva/ PADSONS or imported company machinery like Linde Seed Master, Petkus-400/Petkus A-12 and Heid Austria/ Cimbria Unigrain or any other reputed company.
- 4. The Custom Processor/ Contractor should be able to complete the processing of seeds in both seasons in time limit given as availability of seeds timely for marketing is a crucial parameter for the Custom Processor/ Contractor and MSSCL.
- 5. The Custom Processor/ Contractor should have following trained and professional man-power at the plant:-
- ➤ Plant Engineer/Manager 1 No. having minimum qualification graduate in Agriculture Engineering or B.Sc. (Agril.) and having three years experience of management of seed processing plant and he should have good knowledge of operation and also repair and maintenance of seed processing machinery and crops and varieties and seed certification rules and factory rules and labour and contractual acts.
- ➤ Shift Incharge 1 No. having qualification either Graduate in Agricultural Engineering or B.Sc. (Agril.) or Diploma in Agril. with experience of working at Seed Processing Plant.
- ➤ Operators 2 Nos. having minimum qualification ITI Machinist/ Electrician with two years experience of running seed processing machinery and its repair and maintenance.
- ➤ Processing Assistant/ Store Keeper 2 Nos. having minimum qualification graduate of any branch or diploma in agriculture having two years experience of working at seed processing plant.
- The above staff has to be available throughout the year at the plant and if required for running the plant in three shifts, additional qualified and experienced staff will have to be engaged by the Custom Processor/ Contractor.
- 6. The Custom Processor/ Contractor should be able to run the plant by engaging casual labours/handling labours (Mathadi workers) and professional staff.
- 7. All the statutory requirements related to Plant, Manpower of Custom Processing, Insurance, Factory etc. will be sole responsibility of the Custom Processor / Contractor and MSSCL will not have any obligation regarding any of these.
- 8. The Custom Processor / Contractor must have GST Registration and PAN.
- Certification Agency for running the plant. Building, civil structure and electrification should be safe and should have stability certificate and approved from Govt. Electrical Inspector. All civil hateral columity.

- 10. Godown for storage of seeds should be constructed of RCC and brick work and should have sufficient plinth height of at least 1 to 3 ft. from ground level to avoid dampness and also sufficient ventilation for airation in the godown and good openable shutters/ doors and flooring of PCC or mastic flooring or trimix flooring. Separate godown for storage of low grade, failed seed and processing materials should be available. Storage capacity of the godown is calculated with the norms of 1.25 sq. ft. for each quintal of seed. Soybean seeds stack height should not be more than seven feet or six layers of raw seed bags or 15 nos. of good seed (30 kg.) bags. Thus, sufficient space for the quantum of seeds required is as under;
- Godown for storage of raw seed/ good seed/passed seed 12,500 Sq.ft for 10,000 Qtls (MSSCL will pay for godown storage charges above 10,000 qtl. per season).
- ➤ Godown for storage of low grade/ failed seed and processing materials 2,000 sq. ft.
- Sodown should have brick wall, steel shutters, steel/ wooden ventilator and A.C. Sheets roof preferably instead of G.I. Sheets or powder coated traphered sheets and the height of the godown to eve level should be minimum four meter (13 feet) from plinth level. The godown should be leak proof and well ventilated.
- Separate Seed Processing area of at least 2,000 sq. ft. for machinery and operations should be available.
- > The premises of seed processing plant should have either compound wall or at least barbed wire fencing or chain link fencing to protect premises and for protection of seed processing plant and stock.
- Processing plant building and godown should be located on elevated ground area and should not be nearby river/ Nalla/ stream or should not be located near explosive industry to avoid fire. Similarly location of plant and godown should be away from domestic area.
- 11. Sufficient availability of water for fire hydrant system and drinking purpose should be available at the plant with either from source of water like well, dam, reservoir, MIDC, Corporation or Nagar Parishad.
- **12**. Required number of labours male and female and additional labours should be made available for processing.
- 13. Electric supply of required demand should be available for running the seed processing machinery and electrification. Sufficient lights in the godown and in the open premises of plant should be available and electric bill has to be paid by the custom processor.
- 14. The Custom processor/ contractor should run plant in two or three shifts as per the processing load allotted by MSSCL to complete the processing within time limit given by MSSCL. In case of load shading/ continuous power failure the custom processor / contractor should run the plant by using DG set either own or hired so that processing should be completed within time limit given by MSSCL will not provide DG set, Diesel, oil etc. neither MSSCL will bear any extra expenditure.
- **15**. All the stationery, stamp, sample bags, Pen, Pencil, papers, polyethylene bags required will be supplied by MSSCL.
- 16. Seed certification charges will be paid directly by MSSCL to the Seed Certification Agency. However, shift charges due to low output/shift in the plant charged by SCA will have to be paid by Custom Processors, sitting arrangement having separate office for MSSCL Officers and Seed Certification Agency Officers has to be made by the Custom Processor/ Contractor and the tea/Coffee at least two times in shift has to be arranged by the Custom Processor/ Contractor. All the stationery required by Seed Certification Officers for working at Seed Processing Plant has to be provided by the custom processor.
- 17. Sufficient space for sitting and waiting for seed growers and if required for night halt has to be made by the Custom Processor/ Contractor.
- 18. Rest house for SCA staff for night shifts should be provided by custom processor/ contractor. 19. Sufficient drinking water facility, toilet, bathroom etc should be provided by custom processor/ contractor.
  - 20 Office aftendant to SCA officers are to be provided by custom processor/ contractor.
  - Separate supboard with lock and key arrangement should be provided for SCA and MSSCL to keep record, tags etc while period of processing by custom processor/ contractor.

22. All the staff, labours and handling labours have to be engaged by the Custom Processor/ Contractor.

23. Any injury caused to handling labour, casual labour while working at custom processor/ contractor plant and if compensation is to be paid the custom processor/ contractor will be sole responsible for the same.

24. The Custom Processor/ Contractor has to raise the bill fortnightly and payment will be made by MSSCL at the approved rates within 15 days from the date of receipt of bill to District Manager office with clear certificate from the MSSCL's officer posted at seed processing plant for

supervising the work.

25. The quality of the seed has to be maintained in the storage as well as quality of seeds at the time of processing has to be maintained well as per the directives of MSSCL officers posted at the plant. MSSCL technical staff will direct to operate processing machinery to get best quality minimum possible low grade. All the standard procedures of Seed Certification has to be

followed while processing.

- 26. No excessive shortages should occur in the seed lots of seed growers due to careless handling, leakages and overages, sweeping and cleaning and bad storages and if occurred the Custom Processor/ Contractor will be responsible and amount will be recovered from the Custom Processor/ Contractor for such wastage, excessive shortages in seed stock as well as in processing materials. There should be no shortage in Rabi seeds in processing Rabi season. The increased weight due to moisture should be given to concerned seed growers. In case of theft and fire of seed stock and processing materials or any other material from godown/ premises of Custom Processor/ Contractor, it will be the responsibility of the Custom Processor/ Contractor and cost of such stock/material will be recovered from Custom Processor/ Contractor at selling rates of seed stock and material.
  - 27. The MSSCL will insure the stock and material against fire, theft, thunder storm, hail storm, strikes, agitations, accidents etc. In case of any loss to MSSCL, SCA materials and seed stock at custom processor/ contractor premises then the cost of the same will be recovered from custom processor/ contractor at the selling rate decided by MSSCL.

28. No security or watch and ward charges will be provided by MSSCL and sufficient Security/ watch

and ward has to be provided by the Custom Processor/ Contractor.

- 29. Telephone facility has to be made available at the plant by the Custom Processor/ Contractor for local calls and bill for the local calls will be borne by the Custom Processor/ Contractor and if any outside calls made by the MSSCL's officers for official work that will be reimbursed by MSSCL.
- 30. Custom Processor/ Contractor or his authorized representative should always be present in the plant to attend to the problems of seed growers, labours, handling labours, Seed Certification Agency and MSSCL.
- 31. In case of delay in processing, the penalty @ Rs.20/- per quintal per day will be charged to the Custom Processor/ Contractor for a period of fifteen days and thereafter seed stock will be moved from the plant and it will be processed either at MSSCL own plant or at other plant and full amount of processing expenditures and transport and handling expenses incurred will be recovered in advance.
- 32. For maintaining the seed stock in good condition, cleanliness, sweeping will to be carried out by Custom Processor. The fumigation, spraying and dusting will be carried out by MSSCL. However it will be responsibility of Custom Processor to keep the stock infestation free & in good condition. All the processing material, will be supplied by MSSCL. MSSCL will seal all the godowns and plant buildings of Custom Processors to ensure safety and security of MSSCL stock and material. In no case Custom Processor will deliver the stock or material to any other party or seed grower on his own. Else it will be the responsibility of custom processor.



- All the records at Seed Processing Plant like raw seed receipt register, control register, low grade, failed seed register, seed certification register, samples register etc. will be maintained by MSSCL staff and it will be checked and signed by MSSCL officers. All the raw seed receipts and low grade, failed seed gate pass, MTN will be issued by MSSCL staff to the seed growers, dealers and mSSCL units. The Custom Processor/ Contractor will have to assist in maintaining records and entries in SATHI/ Seed flow portal. The Laptops, Printers, Scanners etc. required for making entries in SATHI/ Seed flow portal will have to be provided MSSCL. All records will be in the entriesin SATHI/ Seed flow portal will have to be provided MSSCL. All records will be in the entries of MSSCL staff.
- 34. Limited staff like Plant Engineer/ Incharge and One Jr. Processing Assistant/Operator may be provided by MSSCL for supervising and running the seed processing plant in three shifts. It will be the responsibility of Custom Processor/ Contractor to provide sufficient staff, labours and handling labours to run the plant and to maintain the records and management and operation of plant. The intimation letters to seed growers will be given by MSSCL officers expenditure.

35. The Custom Processor/ Contractor should keep good liaison with seed growers, MSSCL officers and Seed Certification officers and all concerned Government Officers.

36. MSSCL Regional Committee will decide about eligibility of Technical Bid and the MSSCL reserves right for relaxation of any criteria.

37. Agreement – after the tender is accepted, the successful e-tenderer will have to execute agreement as per Govt. rules on financial turnover i.e. on Rs.500/- for 10 lakhs rupees work thereafter 0.1% of remaining payment. Initially agreement has to execute on Rs.1,000/- Non-Judicial Stamp paper and after completion of this season remaining stamp duty has to be paid by custom processor deposit.

38. Security Deposit: The Successful e-Tenderer will have to remit Security Deposit within 10 days from the date of Agreement, failure of which EMD will be forfeited and contract will be treated as cancelled and order will be placed with other party/parties either from e-Tender or from open market and any excess expenditure incurred by MSSCL, shall be recovered from the defaulting party.

39. With the consent of the Contracted party, EMD or balance amount if any with the Corporation may be converted into Security Deposit.

40. Security Deposit amount will be refunded after the processing contract is over and no objection certificate is issued by concerned District Manager of MSSCL. No any interest will be paid on Security Deposit amount. If the custom Processing is not carried out satisfactory the Security Deposit of the party will be forfeited including all losses to MSSCL will also be recovered. The party will be blacklisted.

**41**. MSSC has reserved the rights of allotment of quantity for processing depends upon actual availability of raw seed.

42. MSSC has reserved right of cancellation of Contract at any time.

43. If the tenderer has worked with MSSC as Custom Processor in past, the performance will be viewed while scrutinizing the Technical Bid.

44. If the tenderer is in black list anywhere, it will be taken into account for while scrutinizing the technical bid.



Payment terms:

The first 75 % of the payment will be released when the raw seed arrival and processing is in progress in two installments.

- 10 % payment of the approved processing charges payment will be released on receipt of raw seed per quintal basis after its weighment, sampling and stacking in godown. If the arrival is in progress, the part payment will be released on actual quantity received in the godown.

- 40 % payment of the approved processing charges will be released after grading is completed/ in

progress on per quintal basis.

- 25 % payment of the approved processing charges will be released after Bagging tagging is

completed/ in progress on per quintal basis.

> Balance 15 % payment will be released after complete processing and receipt of results from Seed

Testing Laboratory/ Quality Control Laboratory.

It will be responsibility of custom processor to return all processing materials with its account to MSSCL and Certification materials to MSSCA with its accounts. Also all records like Control Register, tagging register, tag account register, MTN, Gate Pass and Release Orders etc. should be handed over to MSSCL and MSSCA only after obtaining receipt/ NOC of same then only above 15 % payment will be released. Also all low grade, empty gunny bags, rejected seed and failed seed should be returned to the seed growers.

> Balance 10 % payment will be released after three months after complete dispatches of Certified seed and delivery of lowgrade/failed seed to Seed Growers or by the end of September month for

Kharif Season and by the end of January for Rabi Season whichever is later.

All the payments of Custom Processing will be released by the concerned District Manager's office through RTGS/NEFT only after due verification and certification of Bill from the Incharge of MSSCL deputed at Custom Processing Plant.



## SECTION-II (PART-B) GENERAL TERMS AND CONDITIONS OF CONTRACT

# General Terms and Conditions:

It is the responsibility of the Custom Processor/ Contractor to arrange Generator Set in case It is the responsibility of the MSEDCL or Electricity Company/ Board or supply source and electric power supply is off from MSEDCL or Electricity Company/ Board or supply source and electric power supply to our account of power off will not be tolerated and it will be penalized. delay in processing on deservice and the penalized of the penalized. Therefore, Custom Processor/ Contractor has to arrange Generator Set either on rent or his own for running the plant for electrification such as lighting.

The Custom Processor/ Contractor will seal all the doors and shutters of the plant in presence of MSSCL officers and whenever MSSCL officers are not present or the plant is required to operate except where the MSSCL stock is not stored that can be opened by the Custom Processor/ Contractor. In case of theft of MSSCL stock or delivering seed or any material without knowledge or written order to any other party, entire responsibility will be of custom processor

and losses will be fully recoverable from custom processor.

The Custom Processor/ Contractor will not accept as well as deliver/ dispatch any seed stock from other private or public and Government Seed Company unless permitted in writing after completion of entire processing of MSSCL seed. The Custom Processor/ Contractor has to give first preference of processing of MSSCL seed stock. In case, it is found that the Custom Processor/ Contractor is processing other Company seeds, then suitable penalty will be charged and contract may be terminated.

4. The Custom Processor/ Contractor has to deposit Rs.30,000/-as a Security Deposit with MSSCL and Earnest Money Deposit Rs.15,000/-deposited per location may be converted to Security Deposit on request of party. The Security Deposit will be refunded after successful completion of

the contract and on completion of the agreement period.

5. If it is observed that there is a admixture of good seed, failed seed and low grade or varietal admixture in the good seed intentionally done by the Custom Processor/ Contractor, then the compensation has to be paid by the Custom Processor/ Contractor as all the stock is stored and processed in the Custom Processor/ Contractor's plant.

6. MSSCL reserves the right to terminate the contract of processing at any time with one month's

notice to the Custom Processor/ Contractor without any liability.

#### Basis for Quoting rates for Custom Processing:

The Base Custom Processing Charges are fixed by MSSCL & details of work and rates are given in Annexure-I for regular processing operation of Fresh seed grading & Regrading of Fresh seed with godown facility upto 10,000 Qtls. These rates are Including all Taxes but excluding GST which will be given extra, if applicable, as per actual). The GST will be paid by MSSCL on production of proof of payment by the custom processor for the MSSCL custom processing work under taken at the plant of custom processor. For other taxes, MSSCL will not ask for any receipt of tax payment. However, it is the entire liability of custom processor and custom processor is fully responsible to pay taxes and maintain record on demand from concerned Govt. authorities. The TDS as applicable will be deducted from each billed amount of the Seed Processor/ Contractor.

The processing charges are on raw seed basis for complete processing and considering storage of 10,000 Qtls for a period of 3 months (Kharif and Rabi season 3 months each separately). For storage charges above 10,000 Qtls, MSSCL will pay storage charges as per prevailing storage rate at the same tocation / same district per month (GST separate, if applicable, as per actual). If party has offered/processes quantity more than 10,000 atls.

Price-Bid (BOQ), the Custom Processor/ Contractor has to quote Below or At Par these Base Rates in the percentage form.

For activities other than these Fresh seed grading & Re-grading Fresh seed, if executed, the base rates are fixed i.e. for additional handling & other ancillary works (Table 3 to 7). No hike the base rates are fixed will be done. The scope of Custom Processing includes-Unloading of Raw seed received from seed growers & its weighment (either at Custom Processor godown or at outside godown for local transportation upto custom processing plant, (If already stored outside at MSSCL godown, local transportation will be borne by MSSCL) unloading of raw seed transported from outside godown for processing at custom processing plant, Proper Storage, Entire Processing activity, Storage of Good Seed and later loading of Good/Certified seed after processing for transportation backto outside godown (balance quantity), the unloading of Good/ Certified seed in outside godown will be borne by Custom Processor. The loading of Certified seed for dispatch to dealer either from Custom Plant or outside stored godown (10,000 Qtl.) or from outside godown (balance qty) will also has to be borne by Custom Processor.

Empty packets will be provided by MSSCL for packing, Weighing of good seed and lowgrade, Stitching of good seed bags either with tags and labels or without tags and labels. Stitching of lowgrade gunny bags. Printing tags and labels, good seed bags with all required matter. 7. MRP and other matter printing on good seed bags as desired by MSSCL

8. Dispatches of released seed lots for marketing

9. Returning of failed lots and low grade, empty gunny bags to seed growers

10. Delivery of failed seed / low grade to successful tenderer called by MSSCL.

11. It will be a responsibility of custom processor to process seed to achieve maximum quality with optimum recovery %.

12. There should not be excess shortage while processing as well as while storage. If shortages is excessive or intentional then the same will be recovered from custom processor.

13. It will be a responsibility of custom processor to satisfy seed growers by intimating them about processing, by giving proper attention to them. Behavior with MSSCL seed grower should be courteous and polite.

14. If SCA or MSSCL representative found that grading is not done satisfactory then such quantity is

to be again graded and no additional charge will be given to custom processor.

15. If MSSCL desires to undertake regarding/resampling the same has to be done by custom

processor.

16. Now Govt. has incorporated SATHI portal for Seed Traceability. Custom processor has to make all the necessary entries in the portal and while dispatch of seed all the stock has to be dispatched through QR code scanning and necessary entries in SATHI portal.

17. Entire electrical bills will be paid by custom processor.

18. All expenditure required for office and tea to AO etc will have to be born by Custom processor.

19. All taxes (Except GST, if applicable), levies etc. are to be born by custom processor.

20. Entire certification charges will be paid by MSSCL

21. Responsibility of MSSCL is to provide all processing materials required for packing of good seed. All other miscellaneous processing materials like ink, color, printing facilities, rubber stamps, stencils etc. will have to be provided by custom processor.

22. Accounts of all seed, processing materials and seed certification materials will have to be kept by custom processor. Any loss to the same will be recovered from custom processor.

23. Cleaning and sweeping of plant and godown will not be paid by MSSCL and it is the responsibility of the Custom Processor/ Contractor to engage labours for this operation and also providing one Peon for Certification and MSSCL office. This is the responsibility of the Custom Processor/Contractor and no separate payment will be made for such services.

24. For printing of crops and varieties, MRP at the time of advance tagging and for printing of gunny bags and cloth bags at the time of first grading will not be paid separately and it is the responsibility of the Custom Processor/ Contractor to provide labours for this work.

25. The material like ink, stencil, Slips, etc should also be provided by Custom Processor/ Contractor. Denting all amping of truthful labels and tags is the responsibility of the Custom Processor/ and the labour charges for this are included in the processing contract rate and no separate charges will be paid for this work to the Custom Processor/ Contractor.

Truthful labels shall be supplied by MSSCL. Printing on bags should be either stencil printing or printing. Hand writing on bags will not be allowed. screen printing. Hand writing on bags will not be allowed.

27. Arbitration: It is hereby agreed by the parties that any dispute arising out of or in connection with Arbitration Arbitration shall be conducted by a "Sole Arbitration and Conciliation Act 1996 as this Agreement time. The Arbitration shall be conducted by a "Sole Arbitrator" appointed amended from time to time.
